

CHATSWORTH HIGH SCHOOL
SENIOR PROM TICKET INFORMATION

Prom Location: Harbor House, Marina del Rey

Date: Saturday, May 19, 2007

Cost: \$85.00 per person*

(* 1 Prom ticket is included with the Senior Package. Seniors need to purchase a second ticket for a guest. Forms must be in for everyone attending before tickets can be purchased.)

By Friday, April 20: Prom Information Forms must be completed and turned in to A-6 for pre-approval to purchase tickets. There will be a delay in purchasing tickets for forms turned in after April 20. Seniors with a Senior Package must turn in completed forms in order to go to Prom.

No forms will be accepted after April 30.

Tuesday, April 24 – Friday, May 4: Tickets will be sold only to those students who have been pre-approved. Tickets will be sold before school from 7:15 – 7:40 at the Student Store and in Chancellor Hall at lunch.

Friday, May 18: Tickets will be distributed at lunch in front of A-6. There will be a special bell schedule due to state testing. No tickets will be given out before lunch and seniors are expected to be in classes following lunch.

In order to purchase Prom tickets, students must:

- **Be clear** of all delinquencies, including owed detentions and standards. Students also must have turned in an emergency card to the Health Office. Check the list outside of A-6 to see if you are clear.
- Must present a current **photo I.D.** at the time of purchase. The student and guest must also present Photo ID at the Prom.
- Have the attached **Emergency Information** form completed and turned in by April 20. Be sure the guest information for non-Chatsworth students is complete and includes a copy of a photo ID. If any information on the Emergency Information form changes after it is turned in, a new form must be complete and turned in to A-6 by May 10. This includes changes in the name of guests.

You will be given a receipt at the time of purchase. Keep your receipt to receive Prom tickets.

Tickets for Prom will be distributed Friday, May 18, at lunch outside A-6. Photo ID must be shown to receive the tickets. Chatsworth will be on a special bell schedule due to testing. Seniors are expected to be in classes following lunch.

Both you and your guest will need to present **photo ID** along with the receipt to enter the Prom. All students attending Prom are expected to follow the rules on the reverse side. Read the rules over carefully before completing the Prom forms.
